- Awards:** The 2018 award categories are:
- 1) **Lifetime Achievement in Governance Award Criteria:** An independent director (retired or sitting) who has served over a number of years on two or more corporate or non-profit boards. This individual is recognized by his or her peers and the larger community for personal integrity and leadership to multiple organizations in the area of good governance. This individual's leadership has helped, for example, reshape an organization, restore public trust in an organization or significantly improve performance within an organization.

- 2 & 3) **Leadership in Public Company Governance Award Criteria / Leadership in Private Company Governance Award Criteria:** An independent sitting director recognized by his or her peers as an outstanding leader and current contributor in a public or private company boardroom. This individual's leadership has helped, for example, guide one or more public/private companies pursue a significant business opportunity, improve shareholder returns or manage a crisis or other major change effectively, such as a period of rapid growth, business transformation or financial restructuring.
- 4) **Leadership in Non-Profit Governance Award Criteria:** An independent sitting director recognized by his or her peers for outstanding community leadership through service on a non-profit board. This individual's leadership has helped guide one or more non-profit organizations in, for example, expand or substantially improve service to stakeholders, improve financial viability or manage a crisis or other major change effectively.
- 5) **Private Corporation Board of the Year Award Criteria:** The directors of a corporate board who jointly have provided the guidance to steer a private company through a period of extraordinary growth, major crisis or other unusual development. In the process, the board has significantly protected or enhanced stakeholder value.
- 6) **Public Corporation Board of the Year Award Criteria:** The directors of a corporate board who jointly have provided the guidance to steer a company through a period of extraordinary growth, major crisis or other unusual development. In the process, the board has significantly protected or enhanced stakeholder value.
